Shoals Technologies Group to Expand Manufacturing and Distribution Operations in Sumner County



PORTLAND (February) Shoals Technologies Group officials announced that the company will invest \$80 million over the next five years to expand its existing manufacturing and distribution operations to a new, larger location in Portland, Tennessee.

Shoals will create approximately 550 new jobs over the next five years in Sumner County, bringing the company's total headcount in the region to roughly 1,400.

As part of the expansion, Shoals will relocate its manufacturing operations to a 638,000-square-foot plant at 1500 Shoals Way. The additional staff and larger facility will enable Shoals to better meet its growing customer demand for solar power.

Headquartered in Portland, Tennessee, Shoals Technologies Group is a leading electrical balance of systems (EBOS) provider for solar, energy storage and eMobility. The company serves its customers worldwide from several locations in the U.S.

LAWRENCEBURG (February) Flexco Products of Tennessee, LLC officials announced the company will invest \$17.5 million to establish manufacturing and distribution operations in Lawrenceburg, Tennessee.

Flexco will create 60 new jobs in Lawrence County.

The Tennessee plant will be the company's second U.S. location and will be centrally located to better serve Flexco's customers with more efficient

production and shipping times.

The Wilson County facility will be Bridgetown's second location outside of its West Coast headquarters and 219 new jobs will be created as a result of the project.

Bridgetown's new facility will house multiple manufacturing lines, which will produce nearly 100 million pounds of the company's all-natural, organic and gluten-free snack brands annually and optimize distribution to the East Coast by shortening delivery times and decreasing shipping costs.


Landmark Ceramics plans to create an additional 78 new jobs at its North Main Street location.

Three Counties to Participate in Property Evaluation Program

NASHVILLE (April) Grainger, Polk and Warren counties have been selected to participate in the latest round of the Select Tennessee Property Evaluation Program (PEP).

PEP evaluates potential industrial properties, advising counties on industrial site improvements and where investments may be most beneficial. Since its inception in 2015, PEP has helped improve the inventory of industrial sites and buildings across the state, with more than 443 sites being reviewed.

"Gov. Lee has made it an administrationwide goal to create greater opportunity across all 95 counties because what happens in rural Tennessee impacts all Tennesseans," said McWhorter. "The Select Tennessee Property Evaluation Program is unique to our state and helps communities develop shovel-ready industrial sites to attract new business growth and investment."

PEP originates from TNECD's Select Tennessee Certified Site Program. With assistance from site selection firm Austin Consulting, PEP provides participating counties guidance on site planning for future industrial development projects.

PEP includes an on-site visit by Austin Consulting and TNECD, an educational webinar on the

site selection process and a comprehensive assessment of the strengths and needs of each community's inventory of industrial sites. This assessment also offers recommendations to improve marketability.

"The Property Evaluation Program allows our team to recommend the top property or properties for future industrial development in each participating county," said Jonathan Gemmen, senior director at Austin Consulting. "An intangible benefit of PEP is current and future community leaders building consensus around readying a particular property, and understanding, in most cases, that it's a nearterm priority."

These counties were selected based on the demonstrated local need for industrial properties and the county's ability to assemble properties with viable market potential. The application process begins with a submission of a letter of intent, which is accepted at any time. Upon receipt of the letter, interested communities will receive the PEP application. A new round of communities will be accepted into the program in the fall of 2024 with letters of intent due by July 11, 2024. Visit here to learn more about the program or submit a letter of intent.
